Terms, Conditions, and Disclaimers

I. Definitions:

1. **Applicant** means a natural person or individual seeking financial assistance identified in the Financial Assistance Form.
2. **ICBR Entities** means the Islamic Center of Boca Raton, LLC, the Islamic Center of Boca Raton, Inc. and/or any of its officers, employees or agents acting on its behalf.
3. **Financial Assistance Funds** means monies distributed to Applicant selected by the ICBR Entities to receive financial assistance pursuant to the Financial Assistance Form.
4. **Application** means the Financial Assistance Form as amended or supplemented by the ICBR Entities, including all documents referred to or incorporated therein.

II. Eligibility:

1. After submission of a complete Application, ICBR Entities will review the submission and determine Applicant's eligibility for Financial Assistance Funds. Applicant understands and acknowledges that ICBR Entities does not guaranty the selection, approval of, or distribution of Financial Assistance Funds to Applicant.
2. Applicant understands and acknowledges that submission of an Application to ICBR Entities in no way creates a binding contract for or entitlement to Financial Assistance Funds.
3. Applicant understands and acknowledges that a grant of Financial Assistance Funds is subject to Applicant's compliance with these Terms and Conditions and all other requirements of the Application as stated therein including any amendments or addendums to the same. If Applicant is selected for receipt of Financial Assistance Funds, ICBR Entities may, in its sole discretion, modify the amounts or date on which such funds may be available for distribution.

Application agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged or delivered, any and all such further assurances and documents, and take or cause to be taken all such other action, as shall be reasonably necessary from time to time for ICBR Entities related to the receipt of Financial Assistance Funds.

V. Limitation of Liability:

1. In consideration of the ICBR Entities accepting an Application and request for Financial Assistance Funds, Applicant agrees that ICBR Entities shall not have any liability for, and agrees to protect, indemnify and hold harmless ICBR Entities from and against any and all liabilities, suits, actions, claims, demands, losses, expenses and costs of every kind and nature, including reasonable attorney's fees, incurred by, or asserted or imposed against the ICBR Entities, as a result of or in connection with the Application or receipt of Financial Assistance Funds, except for any such misconduct committed by the ICBR Entities.

Applicant further agrees that all money expended by ICBR Entities as a result of such liabilities, suits, actions, claims, demands, losses, expenses, or costs, including reasonable attorney's fees, set forth in Section V.1 shall be immediately and without notice due and payable by Applicant to ICBR Entities. Applicant's obligation to indemnify ICBR Entities shall survive the Terms and Conditions of this Application.
